- 4. New Business
  - a. Resolution 2024-14 Facility Rental Policy Amendment Tabled from 3.21.2024
    - i. Add liability insurance requirement

Executive Director Andy Wildman attended the Granville Township Meeting to discuss the current facility rental agreement. Everyone agreed to add an industry standard \$1,000,000 liability insurance to rental contract.

Motion made by Trustee Fox, seconded by Vice-Chairperson Costa, Vote 3-0

b. Resolution 2024-15 – Apply to Ohio Senate for OTSCIF funding not to Exceed \$500,000 for the purpose of constructing the Rotary Pavilion at Raccoon Valley Park

The GRD leadership team discussed the cost increases associated with capital projects since the 2020 levy. Paving Wildwood and RVP parks alone cost over \$713,000. With the district's tight capital budget, it makes great sense to attempt to capitalize on the state capital budget. Executive Director Wildman recommends applying to OTSCIF for \$500,000.

c. Resolution 2024-16 - Amend the GRD's Refund Policy

The administrative staff was tasked with evaluating the refund policy and suggesting changes. The former policy included a \$20 admin fee, which seemed high for some registrations. The staff suggested a 12% admin fee, which would more directly reflect each specific program's cost than a flat fee. The board agreed with the concept but asked to lower the fee to 10%.

Motion to amend the resolution to a 10% refund policy Trustee Fox, second by Vice-Chairperson Costa, Vote 3-0



Motion to approve the amended resolution by Vice-Chairperson Costa, second by Trustee Schroeder, Vote 3-0
